



# CORPORATE LICENCE INFORMATION & REQUIREMENTS

## **IMPORTANT INFORMATION:**

An application for a Licence must be lodged in person at the nearest Police Station, or with Police on a Rural Patrol. Applications should not be mailed in directly to the Firearms Policy and Records Unit.

There is no renewal system in the NT - each and every application is a fresh application under the Act, and all supporting documentation must be provided on each occasion.

This evidence should be in the following forms:

### **STATION OWNERS/MANAGERS**

- A copy of your Primary Producers Concession, **or**
- A copy of your business registration (if applicable), **and**
- **A letter** setting out the reason/s for requiring these licence/firearms.

### **PROFESSIONAL FISHERMAN**

- A copy of your **current net or fishing licence/s**,
- A copy of your fisheries returns or a letter from Fisheries demonstrating a personal and continuous use of your fishing licence,
- A copy of current vessel registration,
- A copy of your business registration (if applicable), **and**
- **A letter** setting out the reason/s for requiring these licence/firearms.

### **SAFARI GUIDES/TOUR OPERATORS**

- A copy of your **current tour operators licence/s**,
- A copy of your returns to demonstrate that you are actively trading as a tour operator,
- A copy of current vessel registration if conducting fishing tours (if applicable),
- **A map** detailing the specific concessions (areas) you operate in,
- **If using another safari operators concession** – a copy of the agreement with that company including dates it is valid for,
- **If on Private Property** - a contractual agreement including dates in force for,
- **If on Aboriginal Land** – a letter or agreement from the respective Land Trust or Land Council (letters from individual traditional owners and town councils are not acceptable),
- Supporting documentation – copies of Tourist Vehicle (TV) registration for client transport, public liability insurance, etc,
- A copy of your business registration (if applicable), **and**
- **A letter** setting out the reason/s for requiring these licence/firearms.

## **PET MEAT SHOOTERS**

- A copy of any current pet meat shooting contract and/or slaughter licence,
- A copy of your business registration (if applicable), **and**
- **A letter** setting out the reason/s for requiring these licence/firearms.

## **FIREARM STORAGE**

It is a requirement of being granted a Licence that you must have or have access to approved storage facilities to be eligible for a Licence.

If your Safe Storage arrangements are not already recorded on the Police Firearms database, then an inspection form needs to be completed for your Gun Safe to be inspected. Sign and submit a Permission to Inspect Premises form ('Inspection of premises' - PF482) with your application.

## **FIREARMS TRAINING AND SAFTY COURSE**

Corporate Licence holders **are responsible** for ensuring **all employees** using the Company firearms undertake an approved Firearms Training and Safety Course. The following instructors conduct this course:
