

# Interview a Police Member **Application Form**

A request to interview a Police member attracts a fee pursuant to the Police Administration (Fees) Regulations of **50 Revenue Units** per half hour or part thereof for each Police member that is interviewed. Revenue Units are governed by the Northern Territory Revenue Units Act 2009 and are subject to change 1 July each year.

The Northern Territory Department of Treasury and Finance determine the value of a Revenue Unit for all Northern Territory Government Departments.

This fee must be paid prior to the interview taking place and unfortunately, these fees can **NOT** be waived under any circumstances.

If you submit your form at an NT Police Station, the receiving officer will certify your ID and forward your application to the Information Access Team for you.
