

A request to interview a Police member attracts a fee pursuant to the *Police Administration (Fees) Regulations* of **50 Revenue Units** per half hour or part thereof for each Police member that is interviewed. Revenue Units are governed by the Northern Territory *Revenue Units Act 2009* and are subject to change 1 July each year.

The Northern Territory Department of Treasury and Finance determine the value of a Revenue Unit for all Northern Territory Government Departments.
