### **Shooting association**

If the firearm has a calibre in excess of .38" (9mm) the firearm can only be purchased for and used in a 'specially accredited discipline' as defined in the NT Firearm Regulations 1997.

For a permit to be granted to purchase a category H firearm for use in a 'specially accredited discipline' the member must be a member of the national or international body that administers that discipline. The member holds current affiliation with the following national/international pistol shooting association:
