



AIIMS Level 2 and complex incident training

Overview:

The training package for AIIMS Level 2 and complex incidents includes the following Units of Competency:

- PUAOPE018 – Control a Level 2 Incident
- PUAOPE025 – Manage planning for a complex incident
- PUAOPE023 – Manage operations for a Level 2 incident
- PUAOPE022 – Manage logistics for a complex incident
- Manage the public information function at an incident (non-accredited)

Each unit will generally consist of a 5 day course with pre-course online assignments.

Further pre-requisites for each course are listed under the pre-requisites section.

Training suited to:

Selected members of NT Government (“All Hazards All Agencies” approach) who have been identified to undertake a role in the Incident Management Team (IMT) during declared operations or Level 2 & 3 Emergencies.

Each course has maximum candidate participation of 6 places.

Participant commitment:

Total of 45 hours; consisting of 5 x 8 hour days of class-time and allows 5 hours for pre-course work.

Training program outcomes:

On completion of this training, members will be able to:

- Apply AIIMS principles to their respective roles in all incidents to ensure safe, effective and efficient incident management.
- Demonstrate an understanding of the NT Emergency Management Arrangements (NTEMA) and legislation.
- Undertake the lead role for a functional section within the IMT.

Endorsement

Nominations for this training must be endorsed by their agencies Emergency Management Coordinator or equivalent role.
