Notes:

Participation (attendance) relates to the licence holder taking part in a competitive shooting event. It does not include working bees, range duties or committee meetings.

The use of this participation record does not replace the requirements under the *Northern Territory Firearms Act 1997* and *Firearms Regulations 1997* for the club to maintain attendance records.

Participation records for the previous calendar year are to be submitted to the Firearms Policy and Recording Unit (FPRU) by 31 January each year to show compliance. Records can be emailed to firearmsregistry@pfes.nt.gov.au or copies delivered to FPRU.

Category C shotguns are only permitted to be used in target shooting disciplines conducted by the Olympic Games, Commonwealth Games or at national, international or world championships.

MINIMUM PARTICIPATION RATES

Not less than 4 Target Competition shoots in each year of the licence.

*Note: A minimum of four (4) Target Competition shoots **must** be completed at competitions hosted by the club where the holder is a member. As per Regulation 18(2)(a), competition shoots conducted at clubs where the holder is not a member do not count toward the required minimum yearly shoots.*

A category C shotgun held for sports shooting can only be used at a firearms club **approved** under the *Northern Territory Firearms Act 1997*. A category C shotgun can only be used in accordance with **approved** competition and associated training program and must not be loaded with more than 2 cartridges at a time.
